# Title Overview

- Title I
  - Title I programs are designed to help children meet the state content and performance standards in reading, language arts, and mathematics.
- Title II
  - Title II, Part A, is a 100% Federally funded supplemental educational program that provides financial assistance to improve the skills of teachers and the quality of instruction in core academic subjects in public and private elementary and secondary schools.



# Title Overview Continued

- Title III
  - Title III Part A Language Instruction for English Learners and Immigrant Students provides supplemental funds to LEAs to improve the education of ELLs and immigrant children and youth, by assisting the children to learn English and meet challenging state academic content and standards.
- Title IV
  - The purpose of Title IV Part A is to provide all students access to well-rounded educational opportunities, to improve school conditions for student learning through a safe and healthy environment, and to improve the effective use of technology, therefore, increasing academic achievement and digital literacy of students.

With more than \$7 billion in Elementary and Secondary School Emergency Relief (ESSER) funds allocated to Pennsylvania schools to assist them in preventing, preparing for, and responding to the COVID-19 pandemic, the U.S. Department of Education (USDE) is requiring all entities receiving ESSER funds to report on the use of the ESSER funds.
